1 GENERAL TERMS

1.1 OBJECTIVES OF THIS EXPRESSION OF INTEREST

The primary objective of this Expression of Interest (EoI) is to actively seek expression of interest from companies for establishing Data Center in the state, by availing Gujarat IT/ITeS policy incentives.

This initiative is aimed at strengthening the digital infrastructure that centralizes computing and networking equipment to cater the growing demands of internet connectivity, data security, and emerging technologies such as 5G, AI/ML, IoT, Blockchain, applications and other digital services.

The government has undertaken significant initiatives to bolster data center infrastructure in the state, aiming to drive development activities and fortify the digital ecosystem. Further, the Government shall provide fiscal support in the following way. The detailed incentives are mentioned in the Gujarat IT/ ITeS Policy (2022-27):

'Data Center' means a facility that centralizes computing and networking equipment to collect, store, process and disseminate a large amount of data and applications. Incentives will only be provided for the setting up of tier three or above Data Centers in the state subject to:

- A. A minimum built-up area of 4,000 sq. ft.
- B. A minimum of 150 racks, or IT power consumption of at least 900 KW in racks, or 200,000 processor cores.
